Permit Fee: The Grading Permit Fee, as of July 1, 2007, includes cost of engineering plan review, stormwater management review, preparation of a Public Works Agreement, and site inspections. It is calculated as **\$200 plus \$200 per plan sheet**. If your project was submitted for review prior to July 1, 2007, it falls under the previous fee schedule, which consisted of \$100 for 5,000 to 20,000 sf of disturbance, \$200 for over 20,000 sf of disturbance, and an additional \$100 for stormwater management review.

The Department of Public Works requires three (3) copies of signed and approved plans, sealed by a professional engineer, prior to the issuance of a grading permit (see below). Approved plans should be delivered to:

The following requirements must be met prior to the issuance of a Grading Permit.

- () **Grading Permit Fee paid.**
- () **Notice of approval from Dorchester Soil Conservation District.**
- () **Approved construction plans (3 copies), sealed by a registered Professional Engineer licensed in the State of Maryland, bearing approvals from City Planner, City Engineer, Municipal Utilities Commission, Rescue Fire Company, and Owner.**

Grading Permits issued by the Department of Public Works are for grading, site work, and public improvements – construction only. A separate building permit must be obtained prior to starting building construction/demolition.

Any revision to the approved construction plans must be submitted to the City Engineer for approval.
